Email (Outlook & Exchange Online)

How Microsoft Handles Deleted Emails

Deleted Items Folder

Emails stay here until users manually remove them.

Recoverable Items Folder

After deletion from "Deleted Items," emails remain here for 30 days before being permanently purged.

Retention Policies

Organisations can configure longer retention, but this requires admin setup and management.

Permanent Deletion

After the retention window closes, emails are irretrievably deleted—Microsoft cannot restore them.

Key Takeaway

Microsoft provides a 30-day recovery period for deleted emails. After that, it's gone—unless you're protected by a third-party backup solution.

Files (OneDrive & SharePoint)

What Happens When Files Are Deleted?

Recycle Bin

Deleted files remain accessible here for 93 days.

Second-Stage Recycle Bin

Once removed from the initial bin, files are moved here for an additional 93 days.

Retention Policies

Organisations can configure policies for longer retention, primarily for legal or compliance purposes.

Permanent Deletion

After the 93-day window (or custom retention period), files are permanently purged and unrecoverable by Microsoft.

Key Takeaway

Microsoft offers up to 93 days of file recoverability. Beyond that, your data needs a secure, independent backup solution.



Admin Recovery Options

What Admins and Microsoft Can (and Can't) Do

Microsoft Support

Can only assist with recovery within retention periods. After permanent deletion, there's no recovery path.

eDiscovery & Legal Hold

If configured in advance, some deleted items may still be accessible.

User Account Deletion

When an account is deleted, Microsoft retains associated data for 30 days, after which it's completely wiped.

Backups

Microsoft recommends third-party backup solutions to ensure long-term data protection.

Key Takeaway

If a user is accidentally deleted and 30 days have passed, both their account and all associated data are lost—unless you've backed it up elsewhere.
